ORDER

The appellant has filed the present appeal against the impugned order dated 13.07.2015 passed by the Licensing Authority-cum-Deputy Director of Agriculture, Fatehabad, whereby his Seed License No. S-796 was cancelled.

Briefly, the facts of the case are that the appellant was holder of seed license No. S-796 to sell the seeds. The above license was valid upto 16.05.2015. The appellant applied to the respondent for renewal of the said license on 10.07.2015 and the same was cancelled by the respondent vide order dated 13.07.2015. Hence, the present appeal.

Sh. Ram Kumar, Accountant appeared on behalf of the appellant. He has admitted that the license could not be got renewed in time due to busy in purchase of wheat.

I have heard both the parties and perused the relevant record. Admittedly, the appellant did not apply for renewal of his license within the prescribed period. It has been established that the appellant has contravened the provisions of The Seeds (Control) Order 1983. The explanation given by the appellant does not appears to be genuine and sustainable, however, after taking a lenient view the delay is condoned.

In view of the above, I, M.Shayin, IAS, Director of Agriculture, Haryana exercising the Powers of Appellate Authority under The Seed (Control) Order. 1983, accept the present appeal and set aside the impugned order dated 13.07.2015. The appellant is warned to be careful in future and maintain punctuality in renewing his seed license within the stipulated period.

I order accordingly.
