



**ORDER**

The appellant has filed the present appeal against the impugned order dated 19.07.2015 passed by the Licensing Authority-cum-Deputy Director of Agriculture, Jind, whereby his Seed License No. 2724 was cancelled.

Briefly, the facts of the case are that the appellant was holder of seed license No. 2724 to sell the seeds. The above license was valid upto 10.06.2015. The appellant applied to the respondent for renewal of the said license on 20.07.2015 and it has been informed by the respondent to the appellant that his license has already been cancelled vide order dated 19.07.2015. Hence, the present appeal.


Sh. Paramjit Deswal, Prop. appeared on behalf of the appellant. He has admitted that the license could not be got renewed in time due to his family circumstances.

I have heard both the parties and perused the relevant record. Admittedly, the appellant did not apply for renewal of his license within the prescribed period. It has been established that the appellant has contravened the provisions of The Seeds (Control) Order 1983. The explanation given by the appellant does not appears to be genuine and sustainable, however, after taking a lenient view the delay is condoned.

In view of the above, I, M.Shayin, IAS, Director of Agriculture, Haryana exercising the Powers of Appellate Authority under The Seed (Control) Order. 1983, accept the present appeal and set aside the impugned order dated 19.07.2015 subject to the payment of penalty of Rs.2000/- (Rupees Two thousand only) within a period of 15 days from the receipt of the copy of this order.

I order accordingly.
