**Subject:- Timely submission of Detailed Contingency Bill in relation to Abstract Contingency Bill / Advance Drawn Bills..**

1. Please refer to the instruction no 28/14/2011-5B&C dated 20-08-2013 issued to all Head of the Departments by Finance Department vide which it had been mentioned that system is enabled to stop passing of any Abstract Contingency bill / Advance bill if Detailed Contingency bills corresponding to Abstract Contingency bill drawn more than a month earlier are still to be submitted in treasury for adjustment.

2. Now it has been decided to relax the time limit for following types of advance bills:-

TA Advance Bill	-	3 months
LTC Advance Bill	-	3 months
Medical Advance Bill	-	6 months
Other Advance Bill	-	1 month
