

**Subject: Incurring of expenditure under Plan/Non-Plan schemes.**


Kindly refer to the Finance Department's Memo No. 5/6/2005-5B&C, dated 20<sup>th</sup> April, 2016 on the subject noted above vide which the Administrative Departments were allowed to incur expenditure up to 25% in 1<sup>st</sup> quarter, 20% in 2<sup>nd</sup> quarter, 25% in 3<sup>rd</sup> quarter and 30% in 4<sup>th</sup> quarter without any reference on this account to the Finance Department.

2. Now the Finance Department has decided to allow the Administrative Departments to incur expenditure upto 70% under Plan/Non-Plan object heads upto end of 3<sup>rd</sup> quarter (i.e. 31<sup>st</sup> December, 2016) of current fiscal.






