No. 6/4/2016.-1 Cabinet.— In exercise of the powers conferred by clauses (2) and (3) of article 166 of the Constitution of India, I, Kaptan Singh Solanki, Governor of Haryana, hereby make the following rules further to amend the Business of the Haryana Government (Allocation) Rules, 1974, namely:-

1. These rules may be called the Business of the Haryana Government (Allocation) Fourth Amendment Rules, 2016.
2. In the Business of the Haryana Government (Allocation) Rules, 1974, in the Schedule, for the heading, brackets and signs "FOOD AND SUPPLIES DEPARTMENT (Through the Secretary to Government, Haryana, Food and Supplies Department)", the heading, brackets and signs "FOOD, CIVIL SUPPLIES AND CONSUMER AFFAIRS, DEPARTMENT (Through the Secretary to Government, Haryana, Food, Civil Supplies and Consumer Affairs, Department)" shall be substituted.


