**ORDER**

In compliance of the judgment pronounced by Hon'ble Punjab & Haryana High Court, Chandigarh on 10.12.2015 in CWP No.12282 of 2014 (O&M) – Satya Narain V/s State of Haryana, Sh. Satya Narain, Fieldman O/o Assistant Soil Conservation Officer, Sonapat is hereby promoted as Agriculture Inspector in the pay band of Rs. 5200-20200+ grade pay of Rs. 1900 w.e.f. 22.03.2013 when his junior Sh.Maha Singh, Fieldman was promoted as Agriculture Inspector on following terms and conditions. After promotion he is posted in Sonipat under Assistant Plant Protection Officer, Sonipat against vacant post.

1. The official will be on probation for one year.
2. The promotion of the official is purely on temporary basis and subject to the approval of the Haryana Staff Selection Commission.
3. Their services will be governed under the provisions of Haryana Subordinate Agricultural (Group C) Service Rules, 1993.
4. The certificates of the above officials shall be got verified by his concerned Officer from the relevant University/Institution. If the verification reveals that any certificate, so submitted by them, is false, then they shall be reverted forthwith without any notice and without assigning any reason and without prejudice to such further action as may be taken against them under the provisions of the Indian Penal Code or any other law in force for submission of false certificate.
5. The concerned Officer shall make detailed enquiry in respect of the original documents submitted by the official from the issuing authorities and submit their findings to the Directorate within two months of the joining by the officials. He will be responsible for any delay in this regard.
6. The official shall join the place of posting within 15 days. Request for extension in joining time will not be considered.
