Subject: Amendment in Service Rules of the Departments/ Boards/ Corporations/ Universities to the effect that the Diploma of minimum two years' duration awarded by Haryana State Board of Technical Education, Panchkula is equivalent to 10+2 qualification for the purpose of recruitment.

Your kind attention is drawn to the Haryana Government Notification No. 54/06/2016 - 4 TE dated 08.09.2016 (copy attached) whereby the Government of Haryana has declared that all diploma courses of minimum two years' duration awarded by the Haryana State Board of Technical Education, Panchkula are equivalent to 10+2 qualification for the purpose of recruitment in Government jobs in the State of Haryana.

Now, in terms of advice of Chief Secretary, Govt. of Haryana vide U.O. No.17/20/2015-3GS-II dated 16/18.10.2016, all the Departments/ Boards/ Corporations/ Universities are requested to make amendment in their respective Service Rules for incorporating relevant provisions specifying that all diploma courses of minimum two years' duration awarded by the Haryana State Board of Technical Education, Panchkula are equivalent to 10+2 qualification for the purpose of recruitment in Government jobs in the State of Haryana where 10+2 or equivalent qualification has been prescribed.
