संख्या 6/6/2016-1 मन्त्रिमण्डल.- भारत के संविधान के अनुच्छेद 166 के खण्ड (2) तथा (3) द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए, मैं, कप्तान सिंह सोलंकी, राज्यपाल, हरियाणा, इसके द्वारा, हरियाणा सरकार कार्य (आबंटन) नियम, 1974, को आगे संशोधित करने के लिए निम्नलिखित नियम बनाता हूँ, अर्थात्:-

1. ये नियम हरियाणा सरकार कार्य (आबंटन) छठा संशोधन नियम, 2016, कहे जा सकते हैं।
2. हरियाणा सरकार कार्य (आबंटन) नियम, 1974, में, अनुसूची में, शहरी स्थानीय निकाय विभाग (सचिव, हरियाणा सरकार शहरी स्थानीय निकाय विभाग के माध्यम से) शीर्ष के नीचे क्रम संख्या 21 तथा उसके सामने प्रविष्टियों के बाद, अन्त में, निम्नलिखित क्रम संख्या तथा उसके सामने प्रविष्टियाँ जोड़ दी जाएंगी, अर्थात्:-
"22 राज्य के नगर निगमों के बारे में शहरी परिवहन के कार्यों की देख भाल करना"।

No. 6/6/2016-1 Cabinet.— In exercise of the powers conferred by clauses (2) and (3) of article 166 of the Constitution of India, I, Kaptan Singh Solanki, Governor of Haryana, hereby make the following rules further to amend the Business of the Haryana Government (Allocation) Rules, 1974, namely:—

1. These rules may be called the Business of the Haryana Government (Allocation) Sixth Amendment Rules, 2016.
2. In the Business of the Haryana Government (Allocation) Rules, 1974, in the Schedule under heading Urban Local Bodies Department (Through the Secretary to Government, Haryana, Urban Local Bodies Department) after serial number 21 and entries there against the following serial number and entries there against shall be added at the end, namely:—
"22. To look after the work of Urban Transport in respect of Municipal Corporation of the State".
