



**BEFORE THE DIRECTOR GENERAL AGRICULTURE, HARYANA
EXERCISING THE POWERS OF APPELLATE AUTHORITY UNDER THE
FERTILIZER (CONTROL) ORDER, 1985**

ORDER

The appellant has filed the present appeal against the impugned order dated 05.06.2015 passed by the Notified Authority-cum-Deputy Director of Agriculture, Panipat whereby the renewal of Fertilizer Licence No. PPT-622 was declined.

Briefly, the facts of the case are that the appellant is holder of Fertilizer Licence No PPT-622 which was valid upto 02.01.2015. The appellant applied for renewal of the said Fertilizer Licence on 04.06.2015. As per clause 11(3) of Fertilizer (Control) Order, 1985, the holder of Fertilizer Licence is required to apply for renewal before the expiry of the Fertilizer Licence or within one month from the date of expiry of the validity period. The appellant neither applied for renewal of Fertilizer Licence before the expiry of validity period nor within one month from the date of expiry of validity period, consequently, the renewal of the said license was declined by the respondent. Hence, the present appeal.



Sh. Ved Parkash, Manager appeared on behalf of the appellant. He has admitted that the license could not be got renewed in time due to transfer of the manager.

I have heard both the parties and perused the relevant record.


Admittedly, the appellant could not apply for renewal of the Fertilizer Licence No. PPT- 622 before the expiry of the validity period or within one month from the date of expiry of the validity period due to transfer of the manager. The explanation given by the appellant does not appears to be genuine and sustainable, however, after taking a lenient view the delay is condoned.

In view of the above, I, M.Shayin, IAS, Director of Agriculture, Haryana exercising the Powers of Appellate Authority under The Fertilizer (Control) Order, 1985, accept the present appeal and set aside the impugned order dated 05.06.2015. The appellant is warned to be careful in future and maintain punctuality in renewing his letter of authorization within the stipulated period.

I order accordingly.
