- 1 The officials will be on probation for one year.
- 2 The promotions of above officials are purely on temporary basis and subject to the approval of the Haryana Staff Selection Commission.
- 3 Their services will be governed under the provisions of Haryana Subordinate Agricultural (Group C) Service Rules, 1993.
- 4 The certificates of the above officials shall be got verified by his concerned Officer from the relevant University/Institution. If the verification reveals that any certificate, so submitted by them, is false, then they shall be reverted forthwith without any notice and without assigning any reason and without prejudice to such further action as may be taken against them under the provisions of the Indian Penal Code or any other law in force for submission of false certificate.
- 5 All the Concerned Officials shall make detailed enquiry in respect of the original documents submitted by the officials from the issuing authorities and submit their findings to the Directorate within two months of the joining by the officials. They shall be responsible for any delay in this regard.
- 6 These officials shall join their place of posting within 15 days. Request for extension in joining time will not be considered.
