## THE HARYANA RIGHT TO SERVICE (AMENDMENT) ACT, 2016

AN

ACT

*further to amend the Haryana Right to Service Act, 2014.*

Be it enacted by the Legislature of the State of Haryana in the Sixty-seventh Year of the Republic of India as follows:—

1. This Act may be called the Haryana Right to Service (Amendment) Act, 2016.
2. In sub-section (4) of section 5 of the Haryana Right to Service Act, 2014 (hereinafter the called the principal Act),—
  - (i) for the sign "." existing at end, the sign "!" shall be substituted; and
  - (ii) the following provisos shall be added, namely:—
 

"Provided that if the Designated Officer refuses to receive the application or refuses to issue acknowledgment, the eligible person may submit his application in the office of the First Grievance Redressal Authority stating therein the reasons for so doing, who shall forward the same to the Designated Officer;

Provided further that the notified time limit in such a case shall start from the date when the requisite complete application for notified service is received by First Grievance Redressal Authority."
3. In the third proviso to sub-section (2) of section 7 of the principal Act, for the words "sixty days" the words "thirty days" shall be substituted.
4. In section 10 of the principal Act,—
  - (i) in the existing proviso, for the sign "." existing at the end, the sign "!" shall be substituted; and
  - (ii) after the existing proviso, the following proviso shall be added, namely:—
 

"Provided further that a revision made under this section shall be decided by the Commission within a period of thirty days from the date of receipt of revision."
