Subject: - Revised Sanction of the Scheme for Improvement of Crop Statistics for the year 2013-14(100%CSS)

Ref: - Your Memo. No. 6122/Stat Dated 29-1-2014

In supersession of the sanction issued vide this Department Memo.No.1002--Agri-II(5)-2013/6023, dated 5-4-2013. The Governor of Haryana is pleased to accord revised administrative approval-cum-financial sanction to the continuation of the scheme cited as subject only at a total cost of Rs. 37,00,000/- (Rupees thirty seven lacs only) during the year 2013-14 under the various primary units of appropriation subject to the following conditions: -

- i) No new post will be created under the scheme and no vacant post would be filled up without prior approval of F.D.
 - ii) The proposed pay scale of the post should be in accordance with the latest pay scales approved by the State Government.
 - iii) Expenditure should be within the sanctioned budget provision.
 - iv) The reimbursement of the expenditure incurred under the scheme may be ensured at proper time from Govt. of India.
2. Revised sanction will be issued in case the provision of the scheme is modified at any stage.
3. The expenditure involved will be met out from the budget sanctioned under head " 2401-crop-Husbandry Central Sector Plan Scheme -III Agriculture Economics and Statics (SB-96)-Plan Scheme for Improvement of Crop Statics for the year 2013-14.
4. The headquarters of the scheme will be at Panchkula and will cover the whole of the State of Haryana. The Director of Agriculture, Haryana Panchkula will be the Controlling officer and Joint Director (Statistics) Department of Agriculture, Haryana Panchkula will be the Drawing and Disbursing officer of the scheme.
