- ii) The proposed pay scale of the posts should be in accordance with the latest pay scales approved by the State Government.
- iii) Expenditure should be within the revised sanctioned budget provision.
- iv) The reimbursement of the expenditure incurred under the scheme may be ensured at proper time from Govt. of India.

2. Revised sanction will be issued in case the provision of the scheme is modified at any stage.

3. The expenditure involved will be met out from the budget sanctioned under head "2401-Crop Husbandry-III-Agriculture Economics and Statistics (SB-97) - Central Sector (Plan Scheme) for Timely Reporting Scheme of Estimates of Area and Production of Principal Crops for the year 2013-14.

4. The headquarters of the scheme will be at Panchkula. The Director General Agriculture, Haryana, Panchkula will be the Controlling Officer and Joint Director (Statistics), Department of Agriculture, Haryana, Panchkula will be the Drawing and Disbursing Officer of the scheme.




