

## **SPRINKLERS & UNDER-GROUND PIPELINE**

### **QUOTATIONS (2015-16)**

The details of requisite documents and Terms & Conditions for On-line ([agriharyanaofwm.com](http://agriharyanaofwm.com)) submission of application for supply of UGPL of 75 mm to 200 mm sizes with pressure class of 2.50 kg/cm<sup>2</sup> & 3.20 kg/cm<sup>2</sup> HDPE based and 2.50 kg/cm<sup>2</sup> & 4.00 kg/cm<sup>2</sup> PVC based system; and Sprinkler of 75 mm & 90 mm sizes with pressure class of 2.50 kg/cm<sup>2</sup> HDPE and 75 mm size Aluminum based system are as under:

#### **A. Requisite document**

- i) Copy of BIS licence (First & renewed)
  - a. IS: 14151 (Part-1) -1999 : HDPE bare pipe for UGPL
  - b. IS: 4985 (2000) : PVC bare pipe for UGPL
  - c. IS: 14151 (Part-II) -1999/2008 : Coupled HDPE pipe for Sprinkler
  - d. IS: 7092 (Part-II) -1992 : Aluminum Alloy Tube
  - e. IS: 12232 ( 1996) : Rotating Sprinkler/Nozzle
  - f. IS: 1239 : Riser Pipe
- ii) Copy of DIC/SSI/SME licence issued by the concerned authority for fabricating Aluminum based Sprinkler irrigation system.
- iii) In case of Supplier, authority letter of Manufacturer.
- iv) Manufacturer/Supplier shall give the following undertaking on Rs. 100/- Non- Judicial Stamp Paper-

*"We hereby undertake to provide maintenance and warranty inclusive of replacement of complete defective parts free of cost for three year from the date of installation at the farmers' field. We undertake to provide guarantee of quality assurance of all BIS/ Non- BIS components, either manufactured by us or out- sourced from other company as envisaged in the guidelines of Sprinkler/UGPL system; our company will supply the BIS marked material. We shall abide by quality control provisions given in the guidelines. In case of any complaint regarding quality aspect of any component/designing, we will be fully responsible for the same & would be ready for replacement of component as well as rectification of design, if required, within 15 days of complaint & also subject to departmental action or any other action as provided in law for the time being in force."*
- v) Copy of Agreement executed between the Supplier and Manufacturer.
- vi) Certificate from CIPET/NTH for all major non-BIS components (latest or one year old).
- vii) Manufacturer and Supplier shall furnish a Bank Guarantee of Rs. 5.00 lakh for each system separately (i.e. UGPL & Sprinkler) pledged to the Director General Agriculture, Haryana valid up to 3 years from the date of issue.
- viii) Registration fee of **Rs. 25,000/-**(non-refundable), Bank Draft in favour of Managing Director, HADA payable at Panchkula for each system (UGPL or Sprinkler).

## **B. TERMS & CONDITIONS**

1. The Manufacturing and Supplier firms should have valid VAT registration and PAN Card.
2. Manufacturers of HDPE/PVC pipe should have their own quality testing laboratory.
3. Since the Manufacturers of Aluminum pipe are not supplying the complete Sprinkler irrigation system, thus, the Suppliers may have their own factory for fabricating Aluminum based Sprinkler irrigation system with i) Hydraulic Coupler Fixing Machine for fixing MLC or SLC with Aluminum tube, ii) Hydraulic Pipe end folding Machine for folding male end of Aluminum tube, iii) Power Press with Compressor for making of Aluminum Clamps & Batton, and iv) Testing facility/ Equipments.
4. Supplier firm shall only be enlisted for the systems (HDPE/PVC or both) manufactured by a single Manufacturer.
5. CM/L No., Batch No./Lot No., Manufacturer's name etc. should be engraved on Aluminum pipes & accessories and embossed on HDPE/ PVC pipes and accessories as per norms of BIS specifications.
6. The Supplier firm shall not be allowed to change the Manufacturer till expiry of Bank Guarantee.
7. The Manufacturer and Supplier firms shall ensure to submit the address of Godown situated in the State, correspondence address, billing address and contact No. of authorized person.
8. Manufacturer/Supplier would be allowed to supply only one brand of product. A certified copy of application/registration of Trade Mark from the competent authority should be submitted in support of 'Brand Name' for which the offer has been submitted.
9. Manufacturer and Supplier shall be allowed to raise the bill.
10. Manufacturer shall submit quarterly sale report.
11. Manufacturer shall also submit certified copy of bills for materials supplied to the enlisted Supplier.
12. In case of Aluminum tube, the empanelled firm shall supply the copy of purchase bills of Manufacturer.
13. The empanelled firm shall be bound to supply the material as per BIS specifications.
14. The material and testing fee of pipes & accessories shall be borne by the Manufacturer as per Guidelines.
15. The registration fee will be utilized for the purpose of effective management of Transfer of Technology (ToT), Training of staff & farmers, Exposure visits, Workshops/meetings, Publicity campaign etc.
16. Bank Guarantee, if invoked, shall be en-cashable at Panchkula.
17. Incomplete/ application received after due date will not be considered in any case.
18. The Registration/ Empanelment of firms shall be done once in a year.
19. The validity of empanelment of firms can be extended for one or more year.
20. The reasonability/revision of rates shall only be considered on the basis of 10% hike or decline in the rate of raw material.
21. The Director General Agriculture, Haryana reserves the right to accept or reject any or all the quotations without assigning any reason thereof.
22. Civil Courts in Haryana, within whose jurisdiction any particular system pertains to and which is a point of dispute, shall have jurisdiction in the matter.
23. If any empanelled firm violates any condition of the empanelment and found indulge in unfair means or activities, the decision for suspension of empanelment or Blacklisting of such firm(s) shall be taken accordingly.

However, it is made clear that it is not a Government purchase. The interested Manufacturer/ Supplier may submit the application On-line on Website [agriharyanaofwm.com](http://agriharyanaofwm.com) on or before **25.06.2015 up to 5 PM**. The negotiation of rates quoted by the firms shall be carried out on **30-06-2015 at 11 AM** in the Directorate in the presence of Manufactures and Suppliers. The applicant firms are directed to submit the Registration Fee (DD), Bank Guarantee (Original) and self-attested hard copies of other requisite documents required for both the systems (Separate File) on 30.06.2015, otherwise the firm shall not be eligible for empanelment.
